

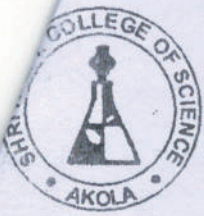


We are pleased to make the MOU with you for the academic sessions 2014-15 to 2018-19 based on the laboratory, library and research facilities available in your college.

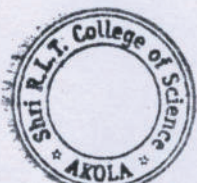

staff members of second party during college hours, with due permission of the Head of Department and In-charge of respective equipments and instruments.


3. Provide the library facility to students and staff members of second party during college hours, with due permission of the Librarian.

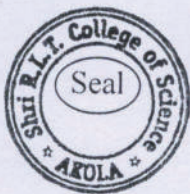
4. Give the priority to students and staff members of second party for attending the guest lectures, workshops and presenting the research papers in conferences, seminars etc. organized by second party.


5. Pay the minimum necessary charges, if required, for availing all above facilities and guidance as per the norms of second party.
