



Terms and conditions-

- Help and support of forest staff for organizing field visit whenever needed.
- To allow use of equipment like Cameras, Laboratory equipments, Binoculars etc. for observation of fauna and flora near waterbodies during field visits.
- Involvement of students by arranging Surveys, Field visits & workshops for the observation of fauna and flora near waterbodies.
- Honorarium of Scientific experts will be provided and should be availed by Forest Department with prior consultation.
- Forest department staff should be involved and sensitised for identification of flora & fauna and capacity building.
- Provisions of the Wildlife Protection Act 1972, Biodiversity Act 2002, 2010 and Ministry of Environment of Forests, Govt. of India March 2011, The wildlife Amendment Bill 2011 & other Forest and Environmental Laws and rules made their under must be adhered strictly.
- Prior intimation/permission of the agency having possession of the water body is mandatory.
- Participation of local people to be encouraged.
- Help from Local NGOs will be taken time to time for arranging various activities.
- This MOU agreement will remain active for five years period from the date of agreement.
- While publishing explored data in scientific communications, publishing author should inform & acknowledge Akola forest division & collaborating NGOs.
- Terms and conditions may be reviewed during Annual review meeting.
- Yearly progress report should be submitted to committee.
