- i) A Master's Degree with 55% marks (or an equivalent grade in a point scale wherever grading system is followed) in a concerned/relevant/allied subject from an Indian universities, or an equivalent degree from an accredited foreign university.
- ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SET or who are or have been awarded a Ph.D. Degree in accordance with the University Grant Commission (Minimum Standards and Procedure for award of M.Phil/Ph.D.Degree) Regulations, 2009 or 2016 and there amendments from time to time as the case may be exempted fromNET/SET.
- iii) Provided the candidates registered for the Ph.D. Degree Programme prior to July 11, 2009, shallbe governed by the provisions of the then existing ordinances/ Bye- Laws/ regulation of the institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SET for recruitment and appointment of assistant professor or equivalent positions in universities/ colleges/ institutions subject to the fulfillment of the following conditions:
 - a) The Ph.D. Degree of the candidate has been awarded in regular mode only.
 - b) The Ph.D. thesis has been evaluated by at least two examiners.
 - c) An open Ph.D. viva voce of the candidate has beenconducted.
